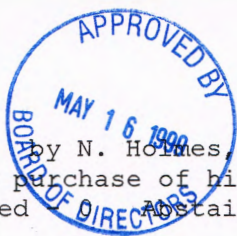

Movie Report. Contract is finalized and paid.

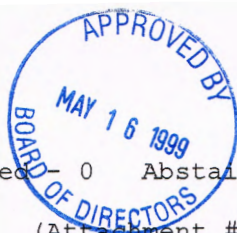
New Business
