We hereby submit specifications and estimates for: **SPRAY POLYURETHANE FOAM & COATINGS**

- Entire roof will be properly cleaned.
- Polyurethane foam [2.8 density] will be sprayed over entire area an average of 1.25 inches thick.
- BENCHMARK BASE COAT will be sprayed on at 1.9 gallons/square.
- PUMA XL [white] will be sprayed over entire area at a rate of 1.9 gallons/square.

Note: Fabric will be imbedded in wet base coat on shed roof on upper end by the wall & the length of the building, approx. 6' wide to reduce potential gashes from snow and ice.

- Roof system will reflect 85% of the sun's heat rays, add an R-value of 7 and has a class A fire rating.
- This roof is warranted against leaks for a period of 12 years. Warranty covers materials and labor. This is a non-prorated warranty!! ***This roofing system is totally seamless and warranty renewable for an indefinite life-span!*
- Building owner will be responsible to move vehicles etc. in danger of over spray.
- Due to unstable roofing material and fuel prices, a surcharge may be added to the final invoice.*

We Propose hereby to furnish material and labor complete in accordance with above specifications, for the sum of:

One hundred fifty nine thousand seven hundred dollars and no cents. (\$159,700.00)

Payment to be made as follows: 40% on signing contract; balance on completion of project.

All material is guaranteed to be as specified. All work to be completed according to standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders and will become an extra charge over and above the estimate. Warranty does not cover damages caused by any third party, including wind-blown debris, birds, leaking condensation lines or HVAC units, kitchen grease exhausts, etc. Owner to carry fire, tornado, and other necessary insurance.
