Department Reports

- *Webmaster* – written report provided.
- *Train Sheet* – written report provided.
 - Eugene Vicknair sent 3 draft articles to Paul and has 2 articles in editing.
- *General Superintendent* – written report provided.
 - David Elems is appointed as Chief Mechanical Officer.
 - Noted we will do annual review of Committees and Departments in August.
- *Historical / Archives* – written report provided.
 - 2023 Convention – 150 attendance, 37 were FRRS members
 - Planning for 2024 Convention.
- *Mechanical*
 - Been doing a lot of admin stuff and getting quotes. Held mandatory engineer's meeting. Next meeting on June 16th for those who missed previous. Need to get everyone on same page with operations and mechanical situations.
 - Got Quincy TR6A 1100 running and released for service.
 - Been doing some repair on WP SW1500 1503, including work on electrical system.
 - Been doing work on SP GP9 2873 as he has time.
 - Received updated quote for radiators for SP 2873 and sent to the Board. Quoted doing 2 different styles of radiator. So far cheapest option is solder bonded radiator rebuild. Would be rebuilt in Texas and shipped to Reno. Waiting on quote from additional supplier. Total cost to get SP 2873 back in operation with radiators rebuilt will be about \$26,000.
 - Discussion about cost and budget for SP 2873 radiators. Consensus direction given to proceed with radiator order. Revise budget to account for cost.
 - Discussion about WP GP20 2001 repairs / radiators. Radiator cost will be around \$36,000 currently. May be \$40,000 by next year. Look for grants for restoration. WP 2001 repairs will be held until 2024. Reminder that when this equipment was donated and / or acquired, they were already worn out. Engines needing new components.
 - Noted that these style radiators are no longer stock items and need to basically be done as custom projects.
 - Discussion about how upcoming emission requirements may / will affect museum part supplies. Some systems may no longer be supported. Using old radiators cores has not been successful and the old stock we have acquired has all proven unusable.
 - Continuing to work on other aspects on SP 2873 such as water pump.
 - Need to do air brake work on several engines. WP GP7 707 is one of them, as are F-units.
 - Trying to get contact info on UP roundhouse guy who wants to help us out.
- *Facilities*
 - Duane has been working on some repair projects around Diesel Shop, including Men's Restroom and deep sink in shop. Repaired some windows lost to snow and worked on Lounge Car.
