In discussions with the President, the president, vice-president and myself will be discussing how to replace the Superintendent of Operations, While the Museum Store staff and Ethan Doty fill in for scheduling the RAL Engineers. As for the Sleeper Coordinator, I will be looking for a replacement person to handle that duty.

WORKING GROUP

The working group has started meeting again. There are several items that if I listed here it would take up too much space, so the important items are:

 - 1. Crew Training Dates May 5th and May 27th (May 27th is an operating weekend)
 - 2. Opening Weekend May 26th
 - 3. 165 Fund Raiser Dinner May 12th
 - 4. Mother's Day May 13th
 - 5. July 4th 2018 is on a Wednesday (middle of the week) Question: Are we running a Caboose Train that day? A Yes or No answer is needed.(need to think about a crew)
 - 6. Railroad Days What Dates (need to plan, Thurs. for Switching, Friday, Sat, & Sun Operations)

The board to really decide how many Train Sheet deadlines (and thus implied issues) per year we are going to have. Paul and I have had an email blast sent out prior to every deadline trying to get material for each issue. (We tell our members that we publish 6 a year)

The board to really decide how many Headlight deadlines (and thus implied issues) per year we are going to have. I have been pushing the current Publisher to get another issue out, he continues to indicate that he is receiving no material from the membership to publish. (We tell our members that we publish 4 a year) The last issue has been over a year ago.

The board to carefully review the Board Meeting dates and times. It seems there is a large amount of confusion about these every year. We need to set Dates and Times and NOT change them unless there is a valid emergency.

Other Items that Need Attention:

- Filming at museum Safety Tailboard Release of Liability Forms Safety Officer present
- The topic if we have an outside group in the property (e.g. a TV film Crew) there is an identified FRRS member who acts as Safety Officer.
