Dear FRRS Board of Directors

The 2020 Election ballots were mailed out to the membership on April 2, 2020 beating the April 20th deadline by a significant margin. I would like to thank Gary McPhettridge and his crew at "Impressive Print" in Red Bluff for getting this out under the circumstances of the Priority jobs he had for this COVID-19 issue. I have attached the printing invoice from "Impressive Print" for the Boards referral for this 2020 election process.

I changed the Ballot Return address from Meade St. in Shasta Lake to Redbud Dr. in Redding for this election year due to some circumstances with one of the Election Committee members at the time of printing and I thought that it would be for the best to change it for the good of the Election process.

One notable looming date for the FRRS Board is May 16, 2020 to whereas per the FRRS Election Policy paragraph 'M', the Board **SHALL**:

"(M)The Board at its May meeting shall select members of the corporation to serve as tellers to count the ballots. These tellers shall be neither, Directors, Candidates, or Relatives, by marriage or birth, of either a Director(s) or a Candidate(s). Tellers are to be selected by the Board of Directors and not the Election Committee."

Now, in conjunction with the above paragraph, If the COVID-19 virus orders stay in effect through the scheduled June 6, 2020 Annual Membership Dinner Meeting and Election announcement, this Committee would like the FRRS Board to consider other alternatives to the standard election policy process. These need to be considered for this election year and for implementing into the Elections Policy for now and such cases in the future that could be enacted by the Board under whatever emergency conditions may arise. Even if they are not needed this election year, the Board needs to consider adding this to the Policy for the Future of the organization. If the Board would like to have one of the Election Committee Members on the call for this subject, just let us know, but I consider this a Board matter to be addressed.
