Introduction

The <u>Entrance and Service Requirements Book</u> contains all of the necessary requirements to enter into and remain in the Feather River Rail Society Train and Engine Service.

- Minimum ages:
 - Train Service is 18
 - Engine Service is 21
 - Junior Train Service program for 16- to 18-year-olds
- No exceptions!
- Each year everyone must:
 - attend annual crew training
 - take and pass the rules examination
 - sign a new liability release

- Must be made available to any proper authority when requested.
- May be carried with you when working in Train or Engine Service.
 - Must be available, for example in your car in the museum parking lot, while on duty.
 - Bring to safety tailboard and post-operations safety meetings.
- May be required to be inspected by the on duty proper authority prior to being assigned to Train
 or Engine Service duties.
- The record section is to be filled out by proper authority when work is completed.
- Persons needing operating hours to maintain qualification will take precedence over other operating personnel.
- To promote up through the Train and Engine Service positions, you must meet all of the requirements, no exceptions.
- You must be a member in good standing of the Feather River Rail Society, with a membership level of Active or above to be in the Operating Department.
