Dear FRRS Board of Directors

The FRRS 2024 Election Year is here for the Board seats presently being held by Board Members Matt Elems, Steve Habeck & Eugene Vicknair.

Nominations opened January 1, 2024, and will be accepted through January 31, 2024. As of January 9, 2024, **NO** nominations have been received by this committee. Nominations can be submitted by voting members of FRRS (IN WRITING) to the Nomination and Election Committee or personally delivered to the Election Committee. E-mail is an accepted form of written communication for the FRRS. Nominations received later than January 31, 2024 will not be accepted and will be rejected.

The nominations and election information has been posted on the WPRM Website home page and on the WPRM Facebook site as well as in the “Train Sheet” just published recently.

Any person eighteen (18) years of age or older who has been a FRRS member of a voting membership unit in good standing for a minimum of one (1) year at the date of the election or appointment shall be eligible to election or appointment as a director.

If members do not receive a ballot by **April 29, 2024** or it was somehow destroyed in the mailing process, they will need to contact this Election Committee in writing at election@wplives.org for a possible replacement.

February 12, 2024	Candidate Statements must be received along with Payment. (Statements to be sent to Board within 5 days of statement closing date.)
February 28, 2024	Board will have until February 28 th to review candidate statements.
March 4, 2024	Last day Nominees may withdraw their name <u>in writing</u> to the Election Committee.
April 15, 2024	Ballots to be mailed out on or before April 15, 2024.
May 11, 2024	Board to select tellers to count ballots and announce time and place of counting.
May 31, 2024	Ballots must be received. No late ballots will be accepted.
June 8, 2024	Annual FRRS General meeting and Election Announcement.
