## **President's Report**

President McClure discussed issues found in trying to move Southern Pacific SD9 4450 from the Hunter's Point location of the Golden Gate Railroad Museum. He requested that a formal business item be placed for April.

The 4450 has several bad wheels and may require the acquisition of 6 idler axles to allow movement. Review is continuing to see if the wheels can be turned to smooth the wheels and render it legal for movement. If we have to purchase axles, it would run about \$1000 each, with a total of \$7500-9000 with related expenses.

The entire GGRM movement train made it to Brightside-PLA and on to Portola with no problems. Noted that the "Clover Plot" rolled well and there were many comments about the professionalism of the operation. Big kudos and thanks are coming from many organizations and specifically GGRM and PLA. Director Stiles noted that the FRRS is definitely leading the way in many aspects of museum operations.

President McClure did note that he was disappointed at the low number of volunteers that came to help with the GGRM move. We did not get the level of help we wanted. On the positive side, we did gain 3 new members and had many others expressing interest.

When the GGRM train returned on Wednesday, March 1, all went well moving the train in to the museum. President McClure thanked the train crew, Matt Parker, Bill Parker, and Loren Ross, for their help.

Gail McClure may or may not be able to attend Winterail and help with the FRRS table due to medical concerns.

# **Director's Reports**

Director Holmes reported on the excursion train arriving in Portola on April 1. He has been asked to help with the train. Plan is that it will be parked on the West Pass. We may need to turn some UP business cars on the balloon loop.

Director Stiles also expressed disappointment with the low turnout to help at GGRM.

Director Parker thanked John Walker, Ed Wagner and Director Vicknair for their help in publicity for the Society. Reported that we are getting some good publicity leads. He also congratulated Gail McClure for becoming a "Qualified Carwoman" at GGRM, having learned how to service and repack journal bearings as part of the work to prep for the move.

President McClure also noted that the Silver Rifle is on a long-term lease to the FRRS for \$1 per year. It is not open to the public, but can be placed on public display. He is intent on getting the WP 0-6-0 165 unloaded as soon as possible.
