Minutes & Reports Web Page

Now that the amount of material on the [Minutes & Reports web page](#) has grown, I added a Google Custom Search tool that allows the web user to search ONLY the material on the Minutes & Reports web page. The search box on the home page returns results from the Minutes & Reports, but it also returns results from anywhere else on the wplives.org website. The new search tool will help users quickly search the Minutes & Reports material for information. Google has changed the requirements for non-profits to create custom search engines without ads. I filled out all the new forms and successfully got the FRRS registered as a non-profit with Google's partner [TechSoup](#).

Migration of Material to frrs.wprm Google Account

As reported earlier, I have been consolidating items related to the society website to use the frrs.wprm Google account. This includes the YouTube video migration previously reported. Since I was working with the Google Custom Search tool for the Minutes & Reports page, I also moved the home page search tool from my Google account to the frrs.wprm account.
