I received the action item to add meta data to attempt to influence how search engine results are returned. By adding code to our web pages we hope to change the snippet that comes back with search results. The existing return (from an incognito) Google search for "run a locomotive" was

The link goes back to our RAL web page. It is interesting that the snippet (chosen by the Google algorithms) picked one line out of the bulleted list at the bottom of the existing page:

diesel fleet for inspection, maintenance, or repair. In the event that this is necessary, that particular loo If none are available\_guests will be offered a rental of greater value\_\_\_\_\_

- specific locomotive requests will be accommodated when possible, substitutions may be necessary.
- Rentals are from mid-April through mid-November (weather permitting) by appointment.
- certificate suitable for framing is awarded after every rental.
- <u>All persons intending to operate a locamative order the age of 18 years old must be signed release of liability.</u>

Nick suggested new metadata that would change it to "The WPRM at Portola, California is home to one of the largest museum collections of diesel locomotives in the country. The museum offers seasonal train rides on historic cabooses, cab rides in historic locomotives and even the opportunity to operate a locomotive in our Run a Locomotive (RAL) program."

I added the suggested meta data and requested Google to crawl the web page to update the snippet. Unfortunately, the resulting snippet was truncated and we got:



Therefore, Nick reworded the meta data and I added the meta data to both the RAL pages and the home pages for the society. I requested Google to crawl the site again. Google crawled the site at Mar 17, 2024, 12:37:16 PM, and updated the RAL snippet as desired:



The team also discussed and made suggestions for a new desktop home page. These changes were implemented 3/18/24.

The major change was to move the boxes for "Visit Us" and "RAL" to the top of the page to increase the visibility of them. A new box for "Summer Weekend Train Rides" was added at the top.

The calendar box moved from the bottom of the page to the bottom of the announcements section.
