THIS AGREEMENT, made and entered into this 30th day of September, 1906, by and between the UTAH CONSTRUCTION COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Utah, hereinafter called the "Contractor", party of the first part and WESTERN PACIFIC RAILWAY COMPANY, a corporation organized and existing under and by virtue of the laws of the State of California, hereinafter called the "Railway Company", party of the second part,

## WITHESSETH:

That, whereas, heretofore the parties hereto entered into a certain contract bearing date October 31, 1905, which contract is known as "Permanent Copy of which is hereto attached and is hereby WHEREAS. provided that therein prov personned shall be commenced index said Perman on October 1st, 1906 unless the desident to other chief officer of the Railway Company | shall ect the Contractor work thereunder at an carlier date, in which ase the Cont eastpris to commence work therehe President or other chief executive officer Company except that by the terms of the said Permanent Contract "F" the Contractor may at any time prior to October 1st, 1906, request in writing the President or other chief executive officer of the Railway Company to direct the Contractor to begin work under said contract in which event the President or other chief executive officer of the Railway Company shall thereupon direct the Contractor to begin work under said Permanent Contract "F" and that the Contractor shall commence work thereunder at the date or dates fixed by the President or other chief executive officer of the Railway

Company in such notice; and

WHEREAS, the parties hereto mutually agree to extend the time when said work shall be commenced under said Permanent Contract "F";

NOW THEREFORE, in consideration of the premises and for other good and valuable considerations paid to each of the parties hereto by and moving from the other, the receipts whereof are hereby acknowledged;

IT IS HEREBY AGREED between the parties hereto as follows: - .

In all other respects, including the provisions relating to the work to be performed, the materials to be furnished, the nature and character of said work and materials, the prices to be paid, the manner, terms and conditions upon which payments are to be made and the time of the completion of work, the said Contract "F" is ratified, confirmed and approved;
