"Sixth: Contract entitled 'Contract K' and dated April 2nd, 1907, "for the doing of certain work in the construction of said railroad between "a point near the east end of Moleen Canyon in the State of Nevada and the "town of Deeth, in the State of Nevada."

" Copies of all of said contracts being on file with the Secretary of this corporation.

"NOW THEREFORE BE IT RESOLVED that the President and Secretary of "this corporation be and the same are hereby instructed to execute said "contracts on behalf of and in the name and under the seal of this corporation.

BE IT FURTHER RESOLVED that the Secretary of this corporation "be and the same is hereby authorized and instructed to deliver to said "Western Pacific Railway Company three copies of this Resolution certified "by him as Secretary and under the seal of this Corporation."

I further certify that said Resolution has not been revoked or repealed and the same is in full force and effect.
