# A Memory Preserved by Paul Finnegan

Similar many of our museum members, my love affair with trains began a long time ago as a small boy. My family often traveled from the big city of Spokane, Washington to their small town roots of Butte, Montana. My favorite mode of transportation for making this journey was always Northern Pathe cific's North Coast Limited. I eagerly looked forward to the return trip home, not to get home, but

rather since we waited for the train leaving Butte in the mid-afternoon on the platform. Unlike the big city where you waited downstairs and couldn't even see the train arrive, in Butte I could feel the train's power and hear it thunder into the station.

Even better than the ride on the train was the wait before the NCL's arrival. My grandfather, Kenneth Julson, would take his only grandson by the hand and walk the length of the platform time and time again. He would explain railroading in terms a five-year-old, then later an eight-year-old, and later still a tenyear-old could understand. There were usually two GP-7s idling in the ready track for the local

work and switching in the yard. Since switching usually fouled the main, when the passenger train was due, the crew would wait on the siding adjacent to the passenger platform and watch the world go by.

With my grandfather's friendly smile he often got us invited up into the cab of the idling locomotive for a visit. I knew no greater joy than a visit in the cab when I was young. Today, the Northern Pacific is gone and the passenger station in Butte is shuttered and bare -- but here in our museum we keep my boyhood memories alive with our Western Pacific GP-7s, 707 and 708

# Facilities Report

The end of the summer season has arrived. The big news is the paving of approximately 400 running feet of the driveway into the museum and the installation of a new paved crossing for member access.

The sleeping car is in the building awaiting the installation of the air conditioning unit. Rewiring the car for 110 volts AC is virtually complete. Mike Barlow from Bishop, CA is a professional electrician and has been ram-rodding the job. Many kudos to Mike for his expertise and perspiration on this job and the electrical upgrade to the membership support facility complex (MSFC), which includes the sleeping car and shower car areas between track 5 and 6. On October 18, Bob Vieira of Sierra Pacific Power Company of Portola, using a cherry picker, removed the last of the old overhead wires that stretched from our main power pole to the building. With this action, this phase of the power upgrade is complete.

Fifteen tons of scrap (plus or minus a few pounds) was removed this summer from the yard area. Due to the low price of scrap metal, nothing in terms of money was received but we did make a hole in the junk pile in the area known as "the island". The city has now allowed us to dump any remaining scrap in their scrap pile located at the town dump at no charge.

The conversion of the SSW/Cotton Belt RBL boxcar into an archives storage unit is underway. Two new members, Ralph Foster and Bart Rohles, from Santa Clara, CA completed the work of painting the interior of the car started by John Walker. They also laid down the sub-floor material necessary before vinyl floor sheeting material can be installed.

The oil house was cleaned out in August by Ken Iverson, myself and John Schroeder, hired for the summer. John is the Student Body President for Portola High School. The job was greasy but needed to be done.

An inspection of the track before railroad photographer's day revealed a list of defects which included missing bolts in switches. Most of the defects discovered were not FRA defects however one broken frog on east track 3 and 4 switch was an FRA defect and had to be welded. The frog has developed another new crack and will have to be changed out. By spring, and before the start of operations, all other noted defects will be remedied.

Toby Smith will be grading a spot by the hill between the parking lot and the picnic area parking lot in order to build a track on which to put the log flats that are currently in Loyalton. Toby will perform this work on October 25th and I hope he will be able to also dig up the water lines behind the shower car so a permanent water line can be installed thus eliminating the dry barrel riser as the only source of water for that car. It is

also my hope to remove the old fire plug in the same area. The fireplug is ancient and not a reliable tool in the event of a fire. A bad plug is worse than no plug because people come to depend upon them for fire suppression. When they don't work, when one needs them to work, the situation becomes exacerbated.

Eventually, I would like to rid the place of all old fire plugs and install a new dry barrel 3" riser pipe suitable for fire fighting, if necessary, located in front of the green baggage car. This had been a fire hydrant there at one time and all of the piping is still in place. This should be an easy installation.

Since my last report, the "Ore" car is out of business. For years there has been "Ore" and "Core" samples languishing in sample cartons. They were wall to wall for half of a 50 foot boxcar and 4 to 5 feet high. Hundreds of cartons marked and recorded somewhere as to a specific location from which they were removed. We were finally given the okay to dispose of these samples. If you want some interesting samples of geology, look out on the backside of the balloon track, there are 3 dump truck loads of them. All the cartons went to the re-cyclers, three bales full.

The projects for the fall still fill a long page, but as each project is completed a large check goes beside that item along with a great deal of appreciation to those that participated in their completion.

# A Memory Preserved

(Continued from page 1)

In 1930 General Motors purchased the Electro-Motive Corporation (EMC), which designed and sold gas-electric cars. GM also purchased Winton Engine Co., the largest supplier of gasoline engines to EMC. Winton also manufactured diesel engines. GM combined these resources and brought to market diesel switchers and passenger locomotives in 1935. The subsidiaries were fully merged into GM by 1941 as EMD, the Electro-Motive Division.

EMD's Road Switcher model GP-7 was the first model using the high hood outside walkway style, that would be used by many units that followed. Western Pacific's GP-7s had dual controls and were at home on locals and main line freights. The original Pyle-National "barrel" style headlights were replaced by twin sealed-beam lamps in the late seventies. The GP-7s closed the door to steam power on the WP, and completed the dieselization of the railroad. They could be MU'ed with the mechanically similar F7s.

The GP-7 was a very successful model. EMD sold a total of 2,729 units. By far, the majority went to U.S. railroads -- 112 units going north to Canada and two went south of the border to Mexico. The design was based on the EMD 567B 16 cylinder 2-cycle diesel engine and developed 1500 horsepower. Each cylinder

measured 18½ x 10 inches. The "567" number comes from the displacement of each cylinder in cubic inches. The engine idles at 275 RPM and redlined at 800 RPM. The total loaded weight is 251,700 pounds. Depending on the gearing, the maximum speed of a GP-7 ranges from 55 to 89 MPH. The fully loaded GP-7 can hold 18 cubic feet of sand, 230 gallons of coolant, 200 gallons of lube oil, and 1500 gallons of fuel. It is 55' 9" long and the maximum height above the rail is 14' 6".

If you want to learn more than you ever really wanted to know about the EMD GP-7 visit the web site, http://gelwood.el.wny.org/manual/gp7opman.html where you can read the operating manual published by EMD.

Both of Portola's GP-7s were built in October 1952 by EMD. The museum's first GP-7, #708, was donated by Union Pacific in 1984. Our operational unit, #707, was retired by UP in 1985 and donated to the museum two years later.

# 1999 Convention Report

On April 16 & 17 1999, 92 people attended the third annual WPRRHS convention held at the Newark-Fremont Hilton Hotel. Convention directors Jim Dias and Thom Anderson did a great job of putting together a well-received group of presenters that resulted in a thoroughly enjoyable gathering.

Clinicians included John Walker presenting material from the Society archives detailing WP's plans for building their own line up the peninsula into San Francisco. Jim Providenza showed how to make era specific models of the F-unit fleet. Tom Moungovan and Don Marenzi showed slides from their collections. For an unusual viewpoint, Rich Forst showed slides taken during cab-rides as a WP employee. Bill Decker showed how to modify the Life-Like GP20 into a high-hood WP version. Dave Pires showed several easily modeled WP flatcars, gondolas and tank cars.

Norman Holmes showed slides he took in the Bay Area before his move to Portola. Dave Stanley presented slide shows on the Sacramento Northern, Tidewater Southern and Central California Traction Co. Vic Neves and Wayne Monger showed their ever-popular WP-theme slide shows.

Saturday evening, following a buffet-style dinner, those attending the banquet were witness to a rare treat in the form of Mr. Harold Meeker, who joined WP as assistant to President Christy in 1966. He regaled those present for over an hour with stories about the inner workings of the railroad that only someone who was there when it happened could tell. Mr. Meeker's presentation was thoroughly enjoyed by all present. The evening was closed out with a viewing of favorite slides brought by the attendees.

Norman and Barbara Holmes brought the PRM gift shop to the convention and did very well in sales. Norman also showed two company films he had converted to video, a training film and an introduction to the railroad containing footage shot in the 1950s and 1960s. - b. Museum Roof repairing and painting of roof could not be done prior to Railroad Days.
- c. Railroad Days two large and 3 small layouts will be displayed at the museum during Railroad Days.
- d. There is a concern regarding the lateness of The Train Sheet.

#### **COMMITTEE REPORTS:**

SALT LAKE CITY 44 TONNER: After much discussion the Board authorized Director Holmes to proceed with the details necessary to return the 44 Tonner in Salt Lake City in its present state back to Portola. In the discussion it was debated as to which manner would be best. Whether it be parting out the unit at the present location or bringing it back as a whole unit. The Board, on a split vote, decided that it should come to the museum in its present configuration. MOTION 1-8/99 2001: Director Stiles gave an in-depth report on the status and condition of Engine 2001. It was his contention that the accident involving this engine was not of any great concern

accident involving this engine was not of any great concern and Director Morgan concurred that a given amount of repair would erase the damage. Director Englert was of the opinion that the engine should be returned to the Museum as soon as possible, however, Director Stiles stated that the obligation to the Yolo Shortline had yet to be fulfilled and until such time as the engine was in running order and that obligation had been met then the engine could be returned to Portola. Director Stiles indicated he was working toward fulfillment of this obligation and would have a report for the Board at the September meeting.

SILVER HOSTEL: As to the retrieval of the Silver Hostel, Director Morgan reported that he will be leaving for St. Louis on August 23rd to prepare and make arrangements for bringing this unit to the Museum as soon as possible.

## **OLD BUSINESS:**

RAILFAIR FINANCIAL REPORT: Director Monger forwarded an in-depth report of his expenditures for Railfair with cor-

roborating receipts. After some discussion this item was tabled until the Treasurer can examine the billings. He will report to the Board in September.

WP BOXCAR 22009: Director Vicknair gave an in-depth report and the A & D Committee recommendations are as follows: 1. The said car is a proper candidate for reuse 2. It is not unique in the collection 3. It is damaged and would be hard to repair The reuse as proposed is potentially unacceptable and the committee asks that the conversion be done in a manner sensitive to the potential concerns of U.P.R.R.

CREDIT CARDS: Director Holmes reported that four credit cards had been procured for use by various individuals to make purchases connected with their duties in performing work for the museum. Discussion followed - the Board decided to withhold distribution of the cards until such time that a meeting with the Treasurer would be held to determine the use, procedure and limits of the cards could be stipulated. A report will be given at the September meeting.

#### **NEW BUSINESS:**

Trainmaster Jim Gidley was present at the meeting and he indicated to the Board that it was his intent to appoint Don Nelson as "Asst. Trainmaster". Also he suggested that the Annual Board Meeting be held on Railroad Days in order to garner a larger attendance from the membership. Also at this time the Glad Hand Award will be proffered and he indicated that on Railroad Days there will be only I train and it will start at noon.

ALCO S-2 SWITCHER AND BUDD CAR: After much discussion concerning these two units which have been offered ... the possible acquisition was referred to the A & D committee for further action. Director Vicknair is to advise the A & D committee of this assignment.

UPCOMING CONVENTIONS: A discussion by the Board as to the merit of member attendance at the ARM & TRAIN CONVENTION . After discussion the Board authorized the following:

- 1. Director Morgan to attend the ARM Convention with expenses not to exceed \$1200.00. MOTION 2-8/99
- 2. Director Holmes to attend the TRAIN convention in Virginia in November. Director Holmes will bring a projected cost to the September board meeting for consideration. Director Holmes has offered to pay his own airfare.
- 3. The Shasta Daylight Convention in Redding will be September 30 October 3. Director Holmes was authorized to attend with hotel and gas expense to be paid by the FRRS in the amount of \$345.00. MOTION 3 8/99

LIBRARY CAR: The Board discussed the Library Car in great length. Work is in progress on this unit for archive storage. Conversion requiring the cutting of a door for easier access was discussed. Director Englert noted that Ken Roller had noted that an interior door could be erected directly behind the sliding doors thereby eliminating the need for intrusion into the existing metal for such access. This idea is to be considered by John Walker and Director Morgan. Wood has been made available for construction of shelving material, however, Email concerns about the utilization of wood in the storage of archives has been received. It was suggested that metal would better serve the art of preservation. Also, the

possibility of other cars being suited for this purpose.

RAL: Director Englert brought forth the possibility of restricting RAL operations to weekdays only and after discussion the Board asked to have Director Englert survey the possibility of such action and the item would be discussed at a future meeting.

PAVING: Director Morgan moved that appropriations in the sum of \$700.00 for the paving of the membership entrance driveway (including preparation of the crossing for crosstie inspection, replacement of defective ties and the installation of guardrails). After minimal discussion the Board approved this action. MOTION 4-8/99

RAIL FAN DAYS: Director Englert moved the Board pay for room and travel for Arthur Lloyd to attend this function in order to promote the C/Z restoration at a booth for the Silver Hostel. The Board was in complete agreement that this was indeed something that would enhance the possibilities of restoring this unit. Expense for this outing not to exceed \$150.00. MOTION 5-8/99

FILES IN SAN FRANCISCO: Director Holmes advised the Board of his desire to journey to San Francisco to retrieve and return 27 file cabinets donated to the museum. After discussion the Board was in agreement that it was in the best interest of the museum for this to occur. Director Holmes was asked to accomplish this in a manner that would be least expensive to the museum.

MUSEUM VAN RETURN: A discussion ensued as to the possibility of the return of the van, belonging to the museum and now being used by Director Stiles in his efforts to maintain Engine 2001. It would be used by the museum to pick-up people at the airport for transport into the museum. Portola City Administrative Officer Jim Murphy indicated that the city had a car that could be used for this purpose and they could make it available if such a need arose, Director Stiles indicated that there was still need for the van at its present location and he desired to retain it. He indicated it would be returned when work was completed on 2001. Director Morgan indicated that it was the original intent to dispose of the van when it was no longer needed at its present location due to the expense of repair and insurance. This item to be continued to the October meeting.

AIMS, GOALS & OBJECTIVES: The Chair indicated that the process of forming an Aims, Goals & Objectives Committee is moving ahead. Information regarding this committee will be forthcoming.

CAMP CAR: The A & D committee will address this project. LUMBER ACQUISITION: Sierra Pacific Industries has donated a considerable amount of lumber, which was originally intended for shelving and storage space in the Library Car, and arrangements are being made for transportation from the Quincy Mill to the museum site. Portola City Administrative Officer Jim Murphy again offered the services of the City to assist in this endeavor. In the event it cannot be used in the library car there are no doubt other possible areas of construction that would be appropriate for its utilization.

TRANSPORTATION ENHANCEMENT ACTIVITIES (TEA): Director Holmes presented a document for the TEA program in which a letter of proposal was exhibited and after some discussion Director Vicknair agreed to take this to the A & D

committee. This would be a good program in which the museum could acquire monies to enhance museum activities. Among those projects that might be considered would be the Silver Hostel. The proposal and request must be in place by September 10, 1999

POLICY: Director Stiles proposed the consideration of developing and adoption of a POLICY PROCEDURES MANUAL. It was decided to definitely pursue such development of a manual such as this as soon as possible.

PAINTING OF RAILROAD TRACKS ON STREET: The Board discussed the painting of the Railroad Tracks on Commercial St. in Portola. Director Englert was uncertain as to the time of application. Director Stiles felt that given the time limitations that perhaps this project should be delayed until next year. The Board directed Director Englert to resolve this issue

Being no further business the meeting was adjourned.

DIRECTOR MORGAN: Director Morgan reported on the possible acquisition of a Camp Car situated in Oroville, negotiations will continue. Both he and Dan Brady gave a report on the ARMS Convention they attended in Vancouver.

#### **OLD BUSINESS:**

Silver Hostel: Due to the seller reneging on the original contract acquisition of this unit is in limbo and from all appearances, unless the seller abides by the original contract, litigation will ensue. The main bone of contention is the sellers intent to remove existing set of trucks and replace them with a set of lesser value. This is not acceptable and the museum will continue to obtain the car in the condition in which it was purchased. 2001: Conversation concerning the return of 2001 to Portola

brought about no resolve and from all appearances, owing to the fact that the engine at this time is inoperable, return should not be expected before Spring.

Salt Lake City Engine: Executive Director Holmes in accordance with the Board action in August will arrange for transportation of this unit from its present location to the museum in Portola. Title and transfer of ownership must be transmitted to the museum prior to removal.

Silver Thrush: Director Vicknair brought to the Board the gist of his efforts to obtain the Silver Thrush and the Board, given the \$110,000.00 price tag, felt this was not doable. Director Vicknair indicated this was not a rush situation; that the owner was amenable to negotiations.

MOTION 13-10/99 - Director Vicknair be authorized to go to LaMirada to inspect the Silver Thrush and continue preliminary negotiations to determine the feasibility of acquisition. Expenses not to exceed \$350.00.

#### **NEW BUSINESS:**

Acquisition of Thomas Phillips Collection: The Board by motion 14-10/99 approved the acquisition of the Thomas Phillips Collection of Western Pacific Historical Documents pursuant to inspection by John Walker with the purchase price not to exceed \$2500.00.

Motion 15-10/99 - To rescind and eliminate the title and office of Contract Officer failed to pass.

Motion 16-10/99 - That all private equipment, furniture and files be removed from the Corporate Office Car and that it be sued by the Corporate officers and the Board of Directors for the business of the F.R.R.S and the museum. Motion denied Motion 17-10/99 - That the F.R.R.S. shall approve the Zephyr Project funding proposal for the restoration of the Silver Hostel and 805A as outlined in the attached document with the exclusion of #6. Motion passed.

Treasurer Brady was instructed by the Board to formulate a policy for the use of Museum credit cards. All Gas cards will be cancelled as of 10/18/99. Chairman Anderson will attend to this matter.

#### **GOOD OF THE ORDER:**

The Chair advised the Board of the intent to move the UP 737 4-4-0 Steam Engine into the covered facility for the start of cosmetic restoration work which would allow this locomotive to become a more attractive static display. Conversation regarding the Ingersol-Rand Engine and its historical value. It has been determined that this is the only one in existence, making it a truly valuable and historical piece of equipment. The Board decided that it should too be placed under cover to preclude further deterioration. Director Morgan asked the Museum to become a part of the formation of the West Association of Railroad Museums. Director Morgan was appointed to represent the Board in the formation procedures.
